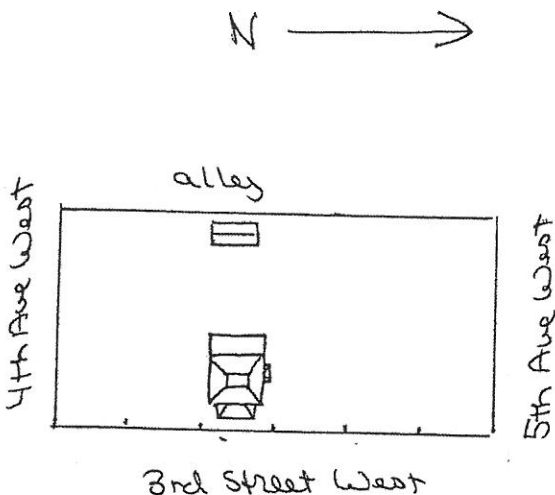

PHYSICAL DESCRIPTION: Describe present appearance of structure/site, then contrast and compare that with it's original appearance, noting additions, alterations, and changes in materials. Discuss significant architectural features.

This rectangular one-story, wood-frame residence has a clipped pyramid hip roof, a hip roof dormer, hip roof side bay, a hip roof three-fourths front porch and a shed roof rear addition. Other features include central brick chimney, enclosed molded face eaves, rectangular fixed single-light dormer window, 1/1 double-hung windows (with large wood surround gone) cement foundation.. The open front porch has solid siding railing and tapered square wood post supports with capitals and base, lattice wood under the porch. Modern materials include asphalt shingles, aluminum siding, aluminum storm windows and doors, and surrounds, an enclosed vertical wood paneled entry area, wood vertical paneling porch rail, a modern wood stove pipe with ash guard.

To the rear of this property is a beveled edge wood sided gable roof garage with corner boards, wood roof shingles, four-light fixed windows, casement hung beveled edge sided garage doors and no foundation.

This is a contributing structure.

HISTORICAL SIGNIFICANCE: Justify how the persons, important events, and/or historical patterns associated with the structure/site and surrounding area lend the property significance.

Ole L. Skeie was a jeweler in Roundup by 1910 and co-owner of Dean and Skeie, watchmakers and jewelers. He owned this property from 1912 to 1925.
